BREEZELESS E CORROSION WARRANTY

Breezeless E carries a 3 - year corrosion warranty on the outdoor unit and 5-years on the outdoor coil.

The unit carries a 3 year performance warranty, where the performance is not affected by corrosion, provided that the maintenance protocol is strictly followed (All other heat load and performance affecting factors will need to be considered in determining the normal working performance).

The Breezeless E Anti - corrosion warranty covers all outdoor working parts as well as structural integrity of the whole unit. T's and Cs apply:

- 1. Service and cleaning protocol A: For installations beyond a 10km radius of the ocean: the unit must be serviced twice annually including a major coil clean quarterly, and this must be done with an alkaline coil cleaner to remove salt build up on fins and copper coils.
- 2. Service and cleaning protocol B: For installations within a 10 km radius of the ocean: the unit must be serviced twice annually as well as a major coil clean every 2 months. Regular coil rinses should be scheduled in addition. An alkaline coil cleaner must be used to remove salt build up on fins and copper coils.
- 3. Industrial and Marine applications should default to protocol B unless specifically agreed with Livance in writing that protocol A may be adopted.
- 4. The onus is on the installer to inform Livance of the intended use type to ensure risk of corrosion is matched to the correct cleaning regime.
- 5. All washes should be done with Neutral (alkaline) PH cleaning solutions and fresh water only.
- 6. Maintenance records should be kept and available for inspection on request.
- 7. The unit must not be splashed with sea/salt water directly.
- 8. Livance Distributors (Pty) Ltd reserves the right to request photographic evidence or physically inspect units in the event of a claim.
- 9. Livance Distributors (Pty) Ltd reserves the right to call for real time proof of maintenance on any site deemed to be high risk at Livance's discretion.
- 10. Any observed potential claim must be brought to Livance's attention within 30 days of its occurrence. Failure to comply will deem the claim invalid.
- 11. The warranty of the unit is held solely with the certified installer, who will be responsible for the upkeep of service records.
- 12. It is a pre-requisite that a meticulous service logbook is maintained and will be inspected for any claim event.

Anti-Corrosion PrimeGuard Hyper Grapfin explained:

- Breezeless E outdoor unit coils have been treated with our patented corrosion resistant treatment Primeguard Hyper Grapfin which has been certified and tested to provide protection beyond the warranted period in a salt contaminated industrial environment.
- The Unit's outdoor electronic components have been corrosion treated.
- The Unit uses stainless screws throughout.
- The Unit outdoor casing has been corrosion treated.

Exclusions:

- 1. The warranty includes a parts/unit warranty and excludes any labour and workmanship.
- 2. The warranty only covers the unit itself and excludes any installation materials or costs or any consequential damages as a result of the unit corroding.
- 3. Any installation damage that removes the treatment and exposes the underlying material will deem the claim invalid.
- 4. Superficial corrosion marking on corners, edges and screw holes is not covered. Warranty covers all working parts, electronic and general structural integrity.
- 5. Maintenance material that causes damage (incorrect washing liquids or cleaning apparatus wired brushes that removes or effects the application in any way)
- 6. Any PCB damages as a result of exposure to moisture (whether from cleaning or exposure to elements) are not covered.
- 7. PCB damages caused by any foreign objects (Geckos etc) are not covered by the standard or corrosion warranty.
- 8. Any damages to the unit, including the PCB, whether accidental or intentional are not covered by warranty.
- 9. PCB damage by voltage fluctuations also voids the warranty, we would strongly recommend over under voltage protection be fitted to mains supply.
